

## Market edged down losing momentum for positive rally

Market closed at **6494.25** points being marginally **negative** by **6.60** points. Market started in a positive note but fluctuated frequently throughout the day and ended negative. Market participation improved remarkably from previous day's level. Yesterday's market participation was 9941.16mn and it increased today than the previous day raising BDT **14109.27** mn turnover which is around **42% higher** than the last day. In term of technical analysis, Index is hovering near a strong resistance at around 6470 points and may be accumulating strength for a positive rally. On the sectoral news fronts, USA's apparel import from Bangladesh increased by 53.54% in January-August compared to the same period of 2021, as it holds the position of the 3rd larg-est apparel import source for the USA. Meanwhile, Bangladesh's imports from the world grew by 37.35% .

Services & Real Estate, Insurance, Miscellaneous, Travel & Leisure and Ceramic were the top gaining sectors, while Paper & Printing, IT, Tannery, Pharmaceuticals and Fuel & Power were the top losing sectors.

BEXIMCO, BXPHARMA, EHL, PUBALIBANK, ORIONINFU mainly moved the index positively. On the other hand, BEACONPHAR, ORIONPHARM, SONALI-PAPR, BSC, KOHINOOR were the negative forces today.

PENINSULA, SKICL, NAVANACNG, FEKDIL, EHL were among the top gainers and BDCOM, TAMIJTEX, BEACONPHAR, AZIZPIPES, APEXSPINN were among the top companies to lose price today.

#### SME Market Update

DSMEX **lost 7.53** points and closed at **1603.92** points which was around 0.5% lower than yesterday. Market participation significantly reduced from yesterday's level. Today's market participations was **55.42 mn** which was **38.6%** lower than yesterday.

APEXWEAV, WONDERTOYS, KFL were the top 3 gainer.


