

#### Market plunged breaking support amid low volume

DSEX had a free fall of **65.45** points closing at **6413.02** points. Market kept sliding down from the very beginning of the session and continued its journey towards the bottom. Market participation fell slightly from previous day's level. Yesterday's market participation was 13431.204 mn and it decreased today than the previous day raising BDT **12978.31** mn turnover which is around **3.4% lower** than the last day. In term of technical analysis, after hovering near a strong support at around 6470 points ,index broke this support in the early session and closed breaking another major support which was at around 6420 points. In term of capital market news fronts, The Bangladesh Securities and Exchange Commission (BSEC) will now form a Shariah council in line with a new rule formulated to make room for more Shariah-based investors in the country's stock market. The commission expects that the move will lead to an increase in the number of Shari-ah-based securities in the market.

All the sectors except Mutual fund closed red today.

BXPHARMA, RAHIMAFOOD, ANWARGALV, MONOSPOOL, ECABLES mainly moved the index positively. On the other hand, BEXIMCO, BEACONPHAR, ORIONPHARM, LHBL, SEAPEARL were the negative forces today.

MONOSPOOL, FINEFOODS, RAHIMAFOOD, ECABLES, EASTERNLUB were among the top gainers and APEXFOOD, FEKDIL, BDCOM, NAVANACNG, APEXSPINN were among the top companies to lose price today.

#### SME Market Update

DSMEX **restored 10.83** points and closed at **1634.40** points which was 0.67% higher than yesterday. Market participation improved appreciably from yesterday's level. Today's market participation was **117.42 mn** which was **170.7% higher** than yesterday.

APEXWEAV, ORYZAAGRO, NIALCO were the top 3 gainer.


